- Due to strain on our staff, their families and to cover potential overtime a \$1 per minute penalty for pick ups after Extended Care end time (5:00pm) will be charged. This fee will be added to the next month's tuition invoice. _____
- I understand and agree that the school reserves the right to dismiss a student whose tuition is two (2) months late. However, every effort will be made to work with those experiencing financial difficulty. Please communicate with the director or administrator about help that might be available. _____
- I understand and agree that to withdrawal my child from RLMS a thirty (30) day notice is required in writing and tuition is due for that time period. _____
